

**PIZZA HUT® BOOK IT!® PROGRAM
GIVE ME TWENTY CHALLENGE SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID IN PUERTO RICO AND WHERE PROHIBITED BY LAW. SWEEPSTAKES IS SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS.

1. **Eligibility:** Entrant must be a legal U.S. citizen 18 years of age as of November 4, 2019, residing in the 50 United States and the District of Columbia who has read for 20 minutes per day for at least five (5) days per week for an eight (8) week period to preschool / pre-kindergarten aged child / children who is / are participating in the Give Me 20 (the "Program"). Upon submission, Entrant will be automatically entered in the Individual Prize Package Sweepstakes.

CLASSROOM PRIZE: If Entrant meets the eligibility requirements for the Classroom Prize Package, Entrant should visit http://bookitprogram.formstack.com/forms/gm20_classroom_entryform to complete and submit the appropriate entry form. Upon submission, Entrant will be automatically entered in the Classroom Prize Package Sweepstakes.

Entrants may enter either for the Individual Prize or the Classroom Prize Sweepstakes by submitting the entry form only once. More than one entry from any person or e-mail address will be void.
